(1) On 14 December 2020, the Company offered 1,027,515 share options pursuant to the terms of the Restricted Discretionary Long-Term Incentive Plan and 7,215,255 restricted stock units (“RSUs”) pursuant to the New Stock Units Plan (please refer to the announcement dated 15 December 2020). As of 31 January 2021, a total of 6,809,408 RSUs were accepted and granted (the remaining 1,027,515 share options and 405,847 RSUs were either declined or not accepted).

(2) As of 31 January 2021, a total of 1,195 RSUs were cancelled.
